**Field Of Study** : **General Food Selling Stream- Product Knowledge**

### What is this course all about?

This unit builds on unit WRRS1B Sell Products and Services. It involves the development of product knowledge and its application to provide sales and service advice to customers with regard to bakery products. It may involve the application of product knowledge in defined areas of food retailing or a more general category according to store requirements.

### When you have finished this course you should be able to demonstrate your ability to:

#### Develop product knowledge – SIRRRPK004A/01

- ❑ Product knowledge developed by accessing relevant sources of information.
- ❑ Comparisons between products researched and applied.
- ❑ Labels read and interpreted according to legislative requirements and store information.
- ❑ Product information is conveyed to other staff members as required

#### Identify bakery products – SIRRRPK004A/02

- ❑ Store bakery product range accurately identified according to product information.
- ❑ Seasonal availability identified according to store information.

#### Recommend bakery products – SIRRRPK004A/03

- ❑ Bakery products and services evaluated according to customer requirements and store policy.
- ❑ Features and benefits discussed with customer to create a buying/selling environment.
- ❑ On-selling, complementary products, specials, new lines, seasonal promotions recommended to customers in line with store policy.
- ❑ Advice on bakery products provided for customers on request.
- ❑ Customer offered alternative product/service or advice when requested item is not available.

## Advise on bakery services – SIRRRPK004A/04

- ❑ Store retail bakery services promoted, quoted on and arranged for customers on request.

  - ❑ ingredients contained in product;
  - ❑ basic dietary and nutritional aspects;
  - ❑ food additives;
  - ❑ flavour of various products;

- ❑ uses and preparation methods;
- ❑ basic production methods;
- ❑ features and use of products;
- ❑ corresponding or complementary products and services
- ❑ Store/industry manuals and documentation (paper based or computerised)
- ❑ Procedures for taking customer orders;
- ❑ Buying and ordering procedures;
  
- ❑ Skills in:
  - ❑ Interpersonal communication skills;
  - ❑ Interpreting store/industry manuals and documentation (paper based or computerised);
  - ❑ reading and understanding product information
  - ❑ reading and understanding store policies and procedures.
  - ❑ Researching product information
  - ❑ pricing, estimation and weighing of quantities

- ❑ industry codes of practice;
- ❑ food safety regulations;
- ❑ health and hygiene
- ❑ transport, storage and handling of goods
